SUMMARY

The Queensland Government released its 2016-17 Grants and Subsidies Program on Friday 9 September 2016 with Expressions of Interest closing on 28 September 2016. The application process requires Council's project endorsement as well as the priority order. Due to the very compressed time frame it has been necessary to have this special meeting.

OFFICER'S RECOMMENDATION

THAT Council resolves to submit Expressions of Interest for the 2016-17 Grants and Subsidies Programs for the following projects:

Furthermore, Council endorses the above sequence as the order of priority.

COMMENTARY

At the time of preparing this report a recommended list of projects had not been completed however will be circulated to Councillors prior to the meeting.

The Queensland Government released its 2016-17 Grants and Subsidies Program on the 9th September with Expressions of Interest closing on the 28th September meaning a very compressed timeframe to complete the application process. This process also requires Council's project endorsement as well as the priority order.

The funding is 60% of the project costs so consequently Council has to fund 40%.

For background information there are three funds -

- 1. Local Government Grants & Subsidies Program (\$28.3M) projects that would keep jobs in regional areas, support growth, innovation & community development including water infrastructure & CBD rejuvenation.
- 2. Community Resilience Fund (\$10M) disaster mitigation infrastructure and reduce vulnerability to natural disasters.
- 3. Natural Disaster Resilience Program (\$6M) to reduce vulnerability to natural hazards and build community resilience. Non local governments can apply.

The guidelines are attached for reference however some further detail is that projects should be 'Shovel Ready', must not commence until funding has been approved and contract signed, must be able to be delivered within 12 months of advice of funding approval and the Minister has absolute discretion in funding decisions. The core objectives of the Programs are to:

- Reduce community vulnerability to natural hazards and build community resilience.
- Support the delivery of infrastructure that meets community needs and increases local employment and growth.

- Deliver key natural disaster mitigation infrastructure.
- Support projects that align with state, regional and local priorities. Councils are not to nominate which fund a project is to be considered under. The projects just need to be endorsed and in priority order.

CONCLUSION

In conclusion it is recommended that Council resolve a list of suitable projects in priority order to be eligible for consideration of funding under the 2016-17 Grants and Subsidies Program.

Introduction

The Department of Infrastructure, Local Government and Planning (the Department) is responsible for administering the following three application based grants and subsidies programs (the Programs):

- Community Resilience Fund (CRF)
- Local Government Grants and Subsidies Program (LGGSP)
- Natural Disaster Resilience Program (NDRP) (jointly funded with the Australian Government).

In keeping with the Department's commitment to reduce the administrative burden on applicants, a streamlined process has been introduced for 2016-17. This includes a new Funding Deed of Agreement that will be executed with eligible organisations, a single smart form for Expression of Interest (EOI) and a fast-tracking option to allow for EOIs to be assessed and funding released sooner.

Objectives and Aims

The core objectives of the Programs are to:

- reduce community vulnerability to natural hazards and build community resilience
- support the delivery of infrastructure that meets community needs and increases local employment and growth
- · deliver key natural disaster mitigation infrastructure
- · support projects that align with state, regional and local priorities.

These objectives are supported by specific program aims (see Attachment A).

Funding

Total 2016-17 funding for the Programs is \$62.3 million, of which \$12 million is provided by the Australian Government under NDRP.

Projects approved for funding under the 2016-17 Programs will be allocated a subsidy of up to **60 per cent** of eligible project costs, which is total project cost, less ineligible costs, less other financial contributions. All applicants are expected to make a financial contribution to the project. While applicants may request a higher subsidy rate, the final funding percentage will be determined at the absolute discretion of the Minister.

Successful applicants will have up to 12 months from the date of formal advice of funding approval to complete the approved project. Additional delivery time may be considered in exceptional circumstances.

Funding may be prioritised for projects where the:

- · applicant has a demonstrated limited capacity to self-fund a project, and/or
- project supports local employment and training opportunities.

Eligible organisations must also meet eligibility criteria relating to the type of project (refer to **Attachment B**) and the project costs (refer to **Attachment C**).

EOI, Assessment and Approval

Eligible organisations are invited to submit an EOI smart form for each project for which funding is sought. The key assessment criteria include:

- · consistency with the objectives and aims of the programs
- · demonstrated need, financial soundness and value for money
- capacity to deliver the project in the required timeframes.

Assessment will be conducted by the Department, consistent with these guidelines.

Applications will be shortlisted and eligible applicants asked to provide additional information.

The Department, however, may fast-track EOIs received under the 2016-17 Programs. That is, there is the potential for the EOI to move directly to Ministerial approval with nil or minimal further information being required. In addition to meeting the key assessment criteria above, projects will be fast-tracked based on the following considerations:

- · size of the requested subsidy
- project priority assigned by the applicant
- project readiness.

The Minister has absolute discretion in funding decisions and is under no obligation to consider submissions made after the Programs have closed.

All applicants will be advised of the outcomes.

- · Ensure the Certification Form is completed and signed
- Review and submit electronically via email, the completed EOI smart form, supporting documentation and Certification Form to 2016-17gsp@dilgp.qld.gov.au.

Key dates:

- Closing date for EOI Wednesday 28 September 2016
- Further information request for shortlisted projects -1-2 weeks after closing
- Fast-tracked projects approved from 12 October 2016
- Remaining projects considered for approval from 26 October 2016.

Attachment A - Aims

Community Resilience Fund (CRF)

The aim of the CRF is to make Queensland communities more resilient to natural disasters, and reduce future expenditure on asset restoration by funding projects that:

- align with the Queensland Strategy for Disaster Resilience, delivering essential disaster mitigation infrastructure
- protect existing essential public infrastructure identified as at risk from natural disasters
- · safeguard residents from the impacts of disasters in identified at risk communities
- · deliver key cyclone and flood mitigation infrastructure
- reduce the risk to Queensland communities of bushfires and other natural hazards
- build partnerships between sectors, and encourage a regional and catchment area approach to mitigation and resilience
- support communities to adapt to the impacts of climate change, thereby reducing the costs of recovery from flood, cyclone and other natural disaster events.

Local Government Grants and Subsidies Program (LGGSP)

The aim of the LGGSP is to support local governments to deliver key infrastructure projects that:

- meet community needs, contributing to sustainable and liveable communities
- · align with state, regional and local priorities
- support economic growth, innovation and community development, increasing local job creation and training opportunities
- contribute to building safe, caring and connected communities, enhancing access to infrastructure and services
- protect public health
- provide efficient and cost-effective outcomes through a regional, collaborative approach.

Natural Disaster Resilience Program (NDRP)

The aim of the NDRP is to reduce Queensland communities' vulnerability to natural hazards and build community resilience by:

- mitigating against or building resilience to Queensland's highest natural hazard risks as identified in the 2012 State-wide Natural Hazard Risk Assessment:
 - flooding (including flash flooding)
 - tropical cyclone winds and storm surge
 - thunderstorm wind gusts, downbursts and tornadoes
 - hail storms
 - bushfires
 - landslides, earthquakes and tsunamis.
- reducing the risk to Queensland communities of bushfires
- providing support to emergency management volunteers

- enhancing community preparedness for natural events through community education and awareness training
- building partnerships between sectors and encouraging a regional and catchment area approach to mitigation and resilience
- contributing towards the action themes of the National Strategy for Disaster Resilience February 2011.

Attachment C – Project Cost Eligibility

Funding is intended only to assist with direct eligible project costs. This includes total project costs less ineligible costs, less other financial contributions to the approved project.

Except where prior written agreement has been reached with the Department to incur such costs, **ineligible** costs include:

- pre-planning activities, including pre-construction, that commence prior to the date of formal advice of funding approval
- · works that have already commenced or been completed
- · duplication of existing initiatives
- · core business for an organisation
- purchase of core business capital equipment such as motor vehicles and office equipment
- · remuneration of executive officers
- temporary works, except where required as part of the construction of the eligible works or required to enable completion of the proposed project
- · land acquisition and associated costs
- · completed feasibility and planning studies
- · conceptual design
- statutory fees and charges and any costs associated with obtaining regulatory and/or development approvals
- legal expenses
- · house raising or relocation
- · furnishings and supplies
- · in-kind contributions
- official opening expenses (excluding permanent signage)
- · ongoing costs for administration, operation and maintenance or engineering
- remuneration of employees for work not directly related to the proposed project
- overhead charges
- vehicle purchasing
- · vehicle leasing, unless directly required for construction, e.g. water trucks, excavators
- · costs of preparing the EOI for funding or associated supporting material.

The above list identifies the most common examples of ineligible costs and is not intended to be comprehensive. If there is any doubt about ineligible costs, please contact the Department.

SUMMARY

This report provides a recommendation to nominate a selected Subcontractor for electrical works in the tender for Stage 2 of the Rockhampton Riverbank Precinct Project.

OFFICER'S RECOMMENDATION

THAT Council approves the nomination of Stankey Electrics Contracting Pty Ltd as a selected Subcontractor for electrical works trade package in the tender for Stage 2 of the Rockhampton Riverbank Precinct Project.

BACKGROUND

The scope of Stage 2, Lower Parklands of the Riverbank Project has been confirmed and tenders will be advertised on 24 September 2016. This stage of the project covers the redevelopment of the lower bank parkland to transform the area into a high quality celebration and recreation urban space. The scope includes construction of a new central plaza area with new grand stairs leading from the upper bank, a new pier structure with café/commercial kitchen and alfresco dining and supporting amenities.

The central activation area will also include the construction of a new water feature and pop jet plaza space and a lift to facilitate access to the lower plaza. The area will be improved with soft landscaping zones, street furniture, public art, way finding signage and improved LED lighting, CCTV and smart technology systems. The area to the south of the central area will include the construction of a creative and challenging shaded play space with slides and play equipment. This area will include the construction of new infrastructure to support events and celebrations. The area will also be improved with soft landscaping zones, street furniture, public art, way finding signage and improved LED lighting, CCTV and smart technology systems. The area to the north of the central area is proposed to include the construction of a new amphitheatre as the centrepiece for this zone. The area will also be improved with soft landscaping zones, street furniture, public art, way finding signage and improved LED lighting, CCTV and smart technology systems.

COMMENTARY

Stankey Electrics Contracting Pty Ltd was the successful tenderer for the Stage 1 electrical works on the project. The scope of works included street lighting, LED lighting, CCTV and smart technology systems. Council has worked closely with Stankey Electrics to develop the smart city model for CCTV/Wi-Fi pole top modules and the integration of these to a central control system. This model will be adopted for Stage 2 of the Riverbank project, and for the proposed CBD Smart City concept.

The continuity provided by the use of the same electrical contractor for subsequent stages of the Riverbank Project provides benefits to Council including a reduced risk of system conflicts, known quality of service and finished product, a single point of contact for warranty issues and ease of future maintenance through a preferred supplier arrangement.

The Stage 1 tender process resulted in the selection of Stankey Electrics as the electrical contractor for the works through a competitive process. They are a local company and have provided a high level of service on works to date. Rates from the Stage 1 tender are available as a benchmark for future works to ensure that value for money is achieved.

LEGISLATIVE CONTEXT

Council's conditions of tender enable the nomination of one or more selected subcontractors in a tender. Selected subcontractors are nominated in situations such as this where benefits are expected to be realised by the Principal (Council) through the nomination of a preferred supplier.

Reference is made to Chapter 6 Contracting clauses of the Local Government Regulation 2012.

Section 235 – Other Exceptions

A local government may enter into a medium-sized contractual arrangement or large-sized contractual arrangement without first inviting written quotes or tenders

if—

- (a) the local government resolves it is satisfied that there is only 1 supplier who is reasonably available; or
- (b) the local government resolves that, because of the specialised or confidential nature of the services that are sought, it would be impractical or disadvantageous for the local government to invite quotes or tenders; or
- (c) a genuine emergency exists; or
- (d) the contract is for the purchase of goods and is made by auction; or
- (e) the contract is for the purchase of second-hand goods; or
- (f) the contract is made with, or under an arrangement with, a government agency.

It is determined that the nomination of Stankey Electrics Pty Ltd as the selected sub contractor for the Electrical Services Package in Stage 2 is based on item b of section 235 of the Act.

The specialised and technical nature of integration of the Smart Technology into Stage 2 is crucial to the overall projects success and the future expansion and maintenance of the Smart Systems for the CBD.

Council have worked closely with Stanke Electrics Pty Ltd to develop functional and compatible IT systems. It would be considered both impractical and disadvantageous for the partnership between Council and Stankey Electrics Pty Ltd not to continue.

Stankey Electrics Contracting Pty Ltd are also on a pre qualified trade supplier arrangement with Council under the 11871- Trade Services panel.

CONCLUSION

It is recommended that the Council approves the nomination of Stankey Electrics Contracting Pty Ltd as a selected Subcontractor for electrical works in the tender for Stage 2 of the Rockhampton Riverbank Precinct Project.
