5. INFRASTRUCTURE CHARGE

The contribution required to be paid is **\$517,259.50**.

This charge may be subject to automatic increases from when the charges are levied until when they are paid in accordance with section 121 of the *Planning Act 2016* and Council's Adopted Infrastructure Charges Resolution (No 5) 2015.

The property falls within Charge Area 3 and the infrastructure charges have been calculated as follows:

- (a) A charge of \$26,495.00 for Gross Floor Area being 757 square metres (office area); and
- (b) A charge of \$440,648.50 for Impervious Area being 51,841 square metres (roof area and hardstand areas for Air Services); and
- (c) A charge of \$50,116.00 for Impervious Area being 5,896 square metres (access and parking areas); and
- (d) There are no Infrastructure Credits applicable.

Therefore a total charge of \$517,259.50 is payable for the development.

No offsets or refunds are applicable for the development.
