6. INFRASTRUCTURE CHARGE

The contribution required to be paid is **\$336,000.00**. This charge may be subject to automatic increases from when the charges are levied until when they are paid in accordance with section 121 of the *Planning Act 2016* and Council's Adopted Infrastructure Charges Resolution (No 5) 2015.

The property falls within Charge Area 1 of Council's Adopted Infrastructure Charges Resolution (No 5) 2015 and the charges have been calculated as follows:

- A charge of \$63,000.00 for Stage 7A (Lot 132, Lot 133 and Lot 151);
- A charge of \$84,000,000.00 for Stage 7B, (Lot 134, Lot 135, Lot 152 and Lot 153);
- A charge of \$63,000.00 for Stage 7C (Lot 136, Lot 154 and Lot 155);
- A charge of \$42,000.00 for Stage 7D (Lot 137 and Lot 156);

- (e) A charge of \$84,000.00 for Stage 7E (Lot 115, Lot 130, Lot 131 and Lot 138); and
- (f) A charge of \$21,000 for the balance lot; and
- (g) An Infrastructure credit of \$21,000 to be applied to the balance lot.

Therefore, a total charge of \$336,000.00 is payable for the development.

No refunds or offsets are applicable to the development.

7. PAYMENT DETAILS

The applicable infrastructure charges for each stage must be paid when the local government issues the Compliance Certificate for the Survey Plan for that stage.
