The local government for Fitzroy Shire adopted this planning scheme, incorporating amendments, on 13 August 2013.

Commencement

This planning scheme, incorporating amendments, took effect on 19 August 2013.

4. State Planning Policy 1/03 – Mitigating the Adverse Impacts of Flood, Bushfire, and Landslide; and
5. The State Coastal Management Plan.
