5. INFRASTRUCTURE CHARGE

The contribution required to be paid is \$78,959.17. This charge may be subject to automatic increases from when the charges are levied until when they are paid in accordance with section 121 of the *Planning Act 2016* and Council's *Charges Resolution (No. 1) of 2022*.

Charges Resolution (No. 1) of 2022 for Reconfiguring a Lot applies to the application. The Infrastructure Charges are as follows:

- (a) A charge of \$122,710.60 for four (4) new allotments; and
- (b) An Infrastructure Credit of \$30,677.65, made up as follows:
 - (i) \$30,677.65 Infrastructure Credit applicable for the existing one allotment.

In accordance with section 3.1 of *Charges Resolution (No.1) of 2022*, the base charge will be automatically increased using the Producer Price Index (PPI), adjusted according to the three (3) yearly PPI average quarterly percentage change between financial quarters; and

In accordance with Development Incentives Policy, section 3.5 of the *Charges Resolution (No. 1)* of 2022, the levied charge will be 85 per cent of the total charge calculated.

The automatic increase and development incentive calculations are reflected in the below table:

The Infrastructure Charge is payable in stages:

- (a) A charge of \$26,319.72 for Stage One (Lot 54)
- (b) A charge of \$26,319.72 for Stage Two (Lot 53)
- (c) A charge of \$26,319.72 for Stage Three (Lot 52)
- (d) No charge for Lot 51 (existing balance lot credit applied)

Therefore a total charge of \$78,959.17 is payable for the development.

No offsets or refunds are applicable for the development.

6. WHEN CHARGE IS PAYABLE

The infrastructure charges of \$78,959.17 must be paid when the local government issues the Approval Certificate for the Survey Plan.
