#### SUMMARY

This report presents a Pest Survey Program for consideration by Council. Prior to Rockhampton Regional Council's pest management staff undertaking property inspections for pest plants, a Pest Survey Program must be approved by Council.

#### OFFICER'S RECOMMENDATION

THAT in accordance with the Land Protection (Pest and Stock Route Management) Act 2002, Council approves the Pest Survey Program, as detailed in the report, for the locality of Alton Downs between Monday 1 September 2014 and Sunday 30 November 2014.

#### **COMMENTARY**

The following identifies the area to be surveyed, the timeframe and other details required by the Land Protection (Pest and Stock Route Management) Act 2002.

#### Survey area

Property inspections will be conducted throughout part of the Rockhampton Regional Council area focusing on the localities of Alton Downs (see attached map).

#### **Area Selection Criteria**

The focus areas are a portion of Rockhampton Regional Council for which inspection by authorised persons is feasible within three months, and are considered a high priority for identifying declared pest plants in accordance with Council's Pest Management Plan.

#### **Program Purpose**

- To monitor compliance with the Land Protection (Pest and Stock Route Management)

  Act 2002 in relation to declared pests
- To aid in monitoring and mapping the distribution and spread of declared plants

#### **Properties Inspected**

Inspections will be conducted on urban and rural properties within the stated areas.

#### **Commencement and Duration of Survey**

This survey will commence on Monday 1 September 2014 and will be in force for a period of three months expiring on Sunday 30 November 2014. Properties will be inspected from 7:00 am to 5:00 pm Monday to Friday.

#### **BACKGROUND**

The Land Protection (Pest and Stock Route Management) Act 2002 requires that prior to a Local Government undertaking property inspections for pests, it must approve a Pest Survey Program.

#### **BUDGET IMPLICATIONS**

The staffing and associated costs to undertake the Pest Survey Program are provided for in the 2014-2015 Natural Resource Management budget

#### LEGISLATIVE CONTEXT

Local Government is responsible for the administration of the Land Protection (Pest and Stock Route Management) Act 2002 (the Act).

The *Act* provides that Local Governments must ensure private property owners are making a reasonable effort to control declared pest plants on their properties. The *Act* identifies the Pest Survey Program as a process for Local Government to assess the level of adherence by private property owners to the various requirements of the *Act*.

#### STAFFING IMPLICATIONS

The inspection program requires the equalivent of one full time pest management officer for the period of the Pest Survey Program.

#### **RISK ASSESSMENT**

An assessment regarding Workplace Health and Safety considerations has identified all activities associated with the implementation of the Pest Survey Program as low risk.

#### **CORPORATE/OPERATIONAL PLAN**

The Pest Survey Program has been identified as an action within Council's Pest Management Plan.

#### CONCLUSION


This report presents to Council a Pest Survey Program for consideration and approval. The implementation of this Pest Survey Program assists Council to fulfill its responsibilities under the Land Protection (Pest and Stock Route Management) Act 2002 by allowing Council to assess the pest plant infestation on private property in the identified focus areas. It also allows Council to assess the property owner's adherence to the various requirements of the Land Protection (Pest and Stock Route Management) Act 2002.





The following is a summary of the activities of the Pest Management Unit for the month of May 2014.

#### **Mount Morgan Field Day**

On 24 May 2014 Council, in conjunction with the Fitzroy River and Coastal Catchment Inc, hosted the Alton Downs Field Day. The aim of the day was to raise awareness of chinee apple, rubbervine and prickly acacia. Topics and demonstrations included control options (chemical and mechanical), chemical applications and associated costs and pasture establishment. The field day was very well received by those that attended.

#### Ridgeland's Show


Pest Management Officers set up a stall at the Ridgelands Show which was well attended, with over 60 landowners approaching the Pest Management Officer with pest management enquiries.

#### **VECTOR MANAGEMENT**

The following is a summary of the activities of the Vector Management Unit for the month of May 2014.

**Surveillance of Fitzroy River:** Scheduled surveillance was undertaken on 17 May 2014 with ten sites sampled of which six sites were found breeding mosquitoes. Breeding on the six sites was below the threshold resulting in no treatment being undertaken.

**Surveillance of Urban Saltmarsh:** Scheduled surveillance was undertaken on three sites. Mosquito breeding found on the sites was below the threshold resulting in no treatment being undertaken.

**Surveillance of Freshwater Areas:** Surveillance of seventeen freshwater sites was undertaken. Mosquito breeding found on the sites was below the threshold resulting in no treatment being undertaken.

**Property Inspections:** Property inspections for dengue management were undertaken on seventeen properties. The inspections found *Aedes aegypti* breeding on one site and eight other sites were found to be breeding other species of mosquitoes. In each case the source of breeding was removed or treated to achieve control.





# Parking Infringements Comparison Year to Date May 2014






# Animal Infringements Comparison Year to Date May 2014


