#### 8.1 LAWRIE STREET FOOTPATH CONDITION

#### SUMMARY

A condition assessment has been carried out on the footpath in front of the commercial area along Lawrie Street, Gracemere.

#### OFFICER'S RECOMMENDATION

- 1. THAT the renewal of the footpath in Lawrie Street, Gracemere be placed in the future works program for consideration during budget deliberations.
- 2. THAT the Department of Transport and Main Roads be consulted with regards to impacts on streetscaping plans as a result of the future upgrade planning for Lawrie Street between the Capricorn Highway and Ranger Street.

#### COMMENTARY

The footpath on Lawrie Street between Platen Street and Russell Street is a mixture of concrete, pavers and asphalt. Visually, the mixture of footpath segments are not particularly inspiring but functionally the footpath segments are still working. The condition assessment undertaken has indicated that the sections of footpath between Platen Street and Russell Street are in fair to poor condition. Some defects warrant rectification under normal maintenance activities and will be passed to Civil Operations for action.

Footpath condition assessments for other business areas have not been undertaken for some time; however, it is thought that the footpath in Lawrie Street is in similar condition to many other footpath segments in high pedestrian areas fronting commercial areas throughout the region.

Streetscape works are being considered by the Parks and Recreation Section for Lawrie Street. If the visual amenity of the footpath is to be improved, renewal of the footpath should be considered in conjunction with this project should it proceed.

Some caution is warranted in the level of investment into streetscape works on the basis of possible changes in the road environment arising from increased traffic volumes and community concerns in relation to pedestrian movements. Traffic counts in Lawrie Street indicate that the traffic volumes near the rail overpass are in excess of 16,000 vpd which indicates that duplication of the travel lanes should be considered for this section of road. As Lawrie Street forms part of the State controlled Gavial to Gracemere Road, Council Officers have raised this issue with Transport and Main Roads and a letter has been forwarded to the relevant Minister in this regard. This issue along with the community raised pedestrian concerns and questions in relation to the upgrade of the Lawrie Street and Ranger Street Intersection indicate that there may be changes to the road environment through this section of road over the coming years. Transport and Main Roads have advised that they are seeking funding for a corridor study for Gracemere – Gavial road in the next financial year.

#### BACKGROUND

Council requested a report be submitted on the irregularities of the footpaths in Lawrie Street, Gracemere. It was understood that the concerns were mainly in relation to the footpath fronting the commercial businesses in Lawrie Street. Council's asset management team were requested to undertake a condition assessment of the footpath for the full block of Lawrie Street from Platen Street to Russell Street.

#### PREVIOUS DECISIONS

On the 30<sup>th</sup> September 2013, Council resolved "That a report be submitted to the next Infrastructure Committee on the irregularities of the footpaths in Lawrie Street, Gracemere".

#### **BUDGET IMPLICATIONS**

Defect rectification should be carried out under normal maintenance budgets. Renewal of the footpath will need to be scoped and costed for inclusion in the forward works programs.

#### CORPORATE/OPERATIONAL PLAN

3.1.1 Consult on, advocate, plan, deliver and maintain a range of safe urban and rural public infrastructure appropriate to the Region's needs, both present and into the future

### CONCLUSION

The footpath on Lawrie Street between Platen Street and Russell Street is visually poor but is still functional. Some defects warrant rectification under normal maintenance activities.



#### COMMENTARY

This report outlines Civil Operations Section's Works Program of planned projects for the months of April - May 2014 (attachment 1), Customer Requests received and completed in March 2014 (attachment 2) and also Urban and Rural Operations Capital Projects Report Financial Year to Date – March 2014 (attachment 3).

#### BACKGROUND

In March, 436 customer requests were received and of those 215 requests were completed. A total of 494 requests were completed for Mach and those received in previous months.

In March there were 328 requests for inspections received with 362 inspections completed in the month; 324 works orders were issued for staff to conduct action from these inspections received, with 331 works orders being completed in March.

#### BUDGET IMPLICATIONS

All works specified in this report are included in Council's current approved budget.

#### LEGISLATIVE CONTEXT

All works outlined in this report will be conducted in a manner to comply with all legislation.

#### STAFFING IMPLICATIONS

#### SUMMARY

Councillor Stephen Schwarten has indicated his intention to move the following Notice of Motion at the next Infrastructure Committee Meeting.

#### COUNCILLOR'S RECOMMENDATION

THAT a report be prepared and presented as soon as practicable to a future meeting of the Infrastructure Committee that investigates the long-standing drainage issue in Kershaw Street, Park Avenue, whereby during moderate to heavy rainfall, storm water backs up and encroaches into the adjacent properties, in some instances flooding beneath Number 54, due to said water being unable to be drained from the kerbing and channelling through the inlet that is roughly in front of the boundary of Numbers 56 and 54 Kershaw Street and the inlet that is directly opposite. Further, that the report provides a strategy for remedying this situation and rough cost estimate of same.

#### BACKGROUND

Councillor Schwarten has submitted the following Notice of Motion:

At the request of a local resident I inspected the flooded roadway in Kershaw Street, Park Avenue, that had resulted from the recent heavy rainfall event. As I drove into the street from Calder Street I took note that water had backed up on both sides of the street so that there were large arcs of water extending out towards the centre of the roadway along the frontage of possibly four or five properties either side of the inlets in the kerbing and channelling.

On alighting from the vehicle I could see that by the time I had arrived on the site much of the water had gotten away; however there was a debris line that showed the extent of the flooding at its highest point, which was well up the concrete driveway at Number 54. I was advised by the constituent concerned that on numerous occasions over the past 10 years water had indeed flooded underneath the dwelling at Number 54.

Very curiously, whilst I was on site and looking at the inlet that was filled to capacity, all of a sudden the level dropped by approximately one metre, to be immediately followed by a rapid draining away of the residual water that had been backed up. This certainly was a curious spectacle to witness.

I took note that the inlets feed into a pipe that by my "guesstimate" would be in the order of 300mm in diameter. This pipe evidently runs under the ground through the property at Number 54 and the corresponding property in Sheehy Street to the rear. I was unable to ascertain where the pipe connects to other drainage.

The bottom line is that there is obviously a problem with this drainage somewhere, which I am now asking be investigated and a report be brought back to the Infrastructure Committee and from there to the full Council on how the problem can be solved and what the approximate cost of this might be.
