#### **SUMMARY**

General Manager Regional Services providing an update on current status of South Rockhampton Flood Levee project including discussion on the calling of tenders and also presentation of options for construction of levee.

#### **COUNCIL RESOLUTION**

#### THAT Council:

- 1. Accept this report on status of project progress and status of compulsory acquisition of private properties for the construction of the SRFL project;
- 2. Accept and approve the recommended panel of Contractors as detailed in the report.
- 3. Approve inviting Tenders for construction of SRFL in two options:
  - **Option (A)** Complete in one go as currently designed and documented.
  - Option (B) Construct Levee in following three stages
    - Stage 1 From Fitzroy Bridge to Quay Street cross over ramp (except Temp Levee section on Quay Street), Flood Gates across QR tracks, Flood Gates across Old Bruce Highway and private property access gate and all concrete works at all three pump stations without electrical and mechanical works.
    - 2. Stage 2 Earthen embankment works and all other remaining works to reach completion and commissioning.
    - 3. Stage 3 Levee operation for three (3) years after completion of Stage 2 works and handing over.
- 4. Approve that under Option (B) Stage 2 works will only be undertaken once additional funding to the extent required to complete SRFL construction work has been secured.
- 5. Approve Option (B) to invite Selective Tenders to construct SRFL in stages as per recommendation (3) above but only commit to construction of Stage 1 works within the current committed project funding of \$65M.
