COUNCIL RESOLUTION

MAYORAL MINUTE

That Council resolves the following:

- 1) That Council receive the verbal briefing from Queensland Health Mr Paul Florian.
- 2) That Council support and resource an office for the purpose of providing a service to our community that accesses various agencies and programmes to find and fill the gaps for those who are impacted by COVID-19. The service is authorised to receive cash and in-kind donations in accordance with any guidelines provided by Rockhampton Regional Council Chief Executive Officer.

3) Events

- a) That Council cancel all public programs and events in all Council facilities for the remainder of March and April with the exclusion of ANZAC Day at this point in time.
- b) That Council hold discussions with the veterans community to discuss ANZAC Day commemorations for 2020 with a view to a smaller representative group conducting a Dawn Service.
- c) That Council cancel all Council run large public events in May 2020 and given the peculiar nature of agricultural shows and their propensity to spread flu and illness, as a precautionary measure, this will include cancelling the Rockhampton Agricultural Show in 2020.
- d) That Council will keep a watching brief for Council organised events or events held at Council facilities in June.
- e) That Council negotiate with organisations who have been the recipient of grants from Council for events scheduled during March, April and May which may need to be cancelled with a view to allowing grants to offset non- recoverable out-of-pocket expenses.
- 4) That Council notes the arrangements made by the Chief Executive Officer and Management Team to ensure business continuity and the continuity of essential community services and commends them for their diligence.
- 5) That, recognising the importance of social distancing and support for those who may find themselves in quarantine or isolation for a period, Council allows and encourages members of the Rockhampton Region Libraries to borrow a larger number of items for a longer period of time as of Thursday 19 March 2020.
- 6) Council is very much aware of the limitations of caretaker period in committing an incoming Council to significant financial commitments. With that in mind, that the Chief Executive Officer undertakes a review of available support programs offered by the Australian and Queensland Governments in response to the COVID-19 pandemic to identify and present for consideration by the new Council, at the earliest opportunity, additional support mechanisms available to Council to assist the business and wider community of Rockhampton, including economic support.
- 7) That in accordance with section 10 of the Disaster Management Regulation 2014 that Mayor Margaret Strelow be appointed the Chairperson and Councillor Tony Williams be appointed Deputy Chairperson of the Local Disaster Management Group for the Rockhampton Local Government Area for the remainder of the current Council term.
