### **SUMMARY**

Council has received a petition from 21 petitioners requesting Council level and bitumen Cairns Lane.

### **RECOMMENDATION**

THAT the petition requesting Council level and bitumen Cairns Lane be received, and that a report be prepared for the Infrastructure Committee.

### **OFFICER COMMENT**

Council has received a petition from 21 residents requesting that Rockhampton Regional Council level and bitumen Cairns Lane, as follows:

"Currently the lane is very difficult to use given that there are areas without bitumen, there are many washouts and/or potholes, and sections of loose gravel. The lane also has a lot of tall grass and weeds growing along the sides which may provide a corridor for unwanted wildlife such as snakes, feral cats, foxes etc. The other laneways in the vicinity (eg Bowen Lane) are all bitumen-sealed and well maintained.

All of the residents whose properties back onto this laneway (Cairns) would like to be able to regularly use it for access to back yards, but are currently limited in doing this, due to its poor condition."
