#### SUMMARY

Author:

The area around Clem Clark Road has been subdivided and the new roads brought up to Council satisfaction. The road network should be included in the Councils Road Asset Register and therefore maintained.

#### OFFICER'S RECOMMENDATION

THAT:

- 1. Council includes the roads as detailed in Attachment 1 of the report (extension of Clem Clark Road, roads marked A and B) in Council's Road Asset Register; and
- 2. Council undertakes a process to name the roads marked A and B in Attachment 1 of the report.

#### COMMENTARY

This area was developed back in the early 1990's, with Council not maintaining the roads in that area.

A further subdivision occurred around 2012 which created a further four allotments. Various issues occurred with the end result being that the development would proceed.

At that time, as per Council's policy, the Developer paid Council to construct the road to a condition that satisfies Council.

This now brings the total number of properties in the area to 12, with a combined road length of 1.75km.

In accordance with Council's policy, Council will need to agree that the road has been built to Council standard.

Council now has upgraded the road network in the area marked C in Attachment 1 and it would then be Council's responsibility to maintain the roads in that area.

#### BUDGET IMPLICATIONS

Note that the budget implications of maintaining the 1.75km section of road would be on average an additional \$20,000 per annum.

#### STAFFING IMPLICATIONS

The road can be maintained by Civil Operations' current staff.

#### CONCLUSION

That the number of different property owners exist and that the roads have been brought to a standard. It would then comply with Council's policy to be included in Council's Road Asset Register and be maintained by Council.
