SUMMARY

Rockhampton Regional Council has the opportunity to apply to the Queensland Government's 2017-19 Local Government Grants and Subsidies Program to seek funding towards the cash costs of projects. This report recommends projects for submission.

OFFICER'S RECOMMENDATION

THAT Council submit the following projects to the 2017-19 Local Government Grants and Subsidies Program, committing a 40% co-contribution towards each project:

1.	Gracemere Sewage Treatment Augmentation Project	\$4.36 million
2.	Boundary Road Upgrade Package	\$1.25 million
3.	Toonooba Park Upgrade Project	\$0.255 million
4.	South Ulam Road Widening Project	\$1.2 million
5.	Park Street Drainage Scheme Stage 5	\$0.75 million
6.	McLeod Park Stage 3	\$0.6 million
7.	Sewer Main Relining in Flood Prone Areas	\$2.04 million

Furthermore, that project prioritisation is indicated by the numerical order above.

COMMENTARY

The \$60 million 2017–19 Local Government Grants and Subsidies Program (the Fund) opened for applications on the 28th August and will close on 6 October 2017.

The following projects are recommended for submission, in order of recommended priority:

- 1. **Gracemere Sewage Treatment Augmentation Project** (\$4.36 million): 2017/18 to 2018/19 works elements to augment the Gracemere Sewage Treatment Plant.
- 2. **Boundary Road Upgrade Package** (\$1.25 million): Widening Kidd St to Norman Rd including intersection upgrade with Norman Road.
- 3. **Toonooba Park Upgrade Project** (\$0.255 million): Installation of park amenities and facilities including bbg and covered seating.
- 4. **South Ulam Road Widening Project** (\$1.2million): Widening works for community road safety.
- 5. **Park Street Drainage Scheme Stage 5** (\$750,000): Extension of successful drainage scheme to areas along Tung Yeen St.
- 6. **McLeod Park Drainage Scheme Stage 3** (\$600,000): Extension of successful drainage scheme to areas in Hook and Donnollan Streets.
- 7. **Sewer Main Relining in Flood Prone Areas** (\$2.04 million): 2017/18 to 2018/19 works to protect against flood water infiltration and associated public health risks.

BACKGROUND

This section provides background in regards to Council's the current round of the Fund and lists the projects Council submitted in the previous round.

1. About the 2017-19 Local Government Grants and Subsidies Program

The aim of the Fund is to provide up 60% in funding assistance to support local governments to deliver key infrastructure projects that:

- meet community needs, contributing to sustainable and liveable communities
- · align with state, regional and local priorities
- support economic growth, innovation and community development, increasing job creation for local communities
- contribute to building safe, caring and connected communities, enhancing access to infrastructure and services
- support Queensland communities to be more resilient to natural disasters and reduce future expenditure on asset restoration.

Importantly, this round excludes the Natural Disaster Resilience Program (NDRP). On that basis, Council has received advice from the Department that study projects to inform the design of flood mitigation infrastructure will be ineligible if submitted as projects for funding.

2. The 2016-17 Local Government Grants and Subsidies Program

Another point of background is that Rockhampton Regional Council applied to the 2016-17 Local Government Grants and Subsidies Program.

BUDGET IMPLICATIONS

Applications to the fund will require a cash co-contribution commitment of at least 40%.

All projects recommended have provisions available for the required co-contributions in the existing 2017/18 and 2018/19 capital budget of the approved 2017/18 Rockhampton Regional Council Budget, with the exception of the Toonooba Park Upgrade Project that is a proposed new project. The co-contribution provisions required for the two drainage scheme project applications are proposed to be sourced from the \$1.5 million allocated to 'Stormwater CP427' in the Capital Budget (line 692). The total of the two co-contributions that would be taken from this budget element is \$0.54 million.

STAFFING IMPLICATIONS

Project delivery will require in-kind contributions from Council in the form of staff time.

RISK ASSESSMENT

Every project awarded funding will be required to have a project risk assessment completed and be registered in the projects section of the Rockhampton Regional Council risk register.

CORPORATE/OPERATIONAL PLAN

This report relates to Corporate Outcome 1.2 of the 'Regional Infrastructure and Facilities' community expectation associated with the Community theme of the Corporate Plan.

CONCLUSION

Rockhampton Regional Council has the opportunity to seek funding from the Queensland Government by submitting projects to the 2017-19 Local Government Grants and Subsidies Program.
