### SUMMARY

This report that highlights the process followed for improving high risk traffic locations in the region and provides an update on the outcome of the previously submitted Blackspot funding applications (2018/19). The report identifies potential projects currently being investigated for submission as part of the next round of Blackspot funding (2019/20).

### OFFICER'S RECOMMENDATION

THAT Council receive this report as an update on the Blackspot funding applications for 2018/19 and endorse the proposed projects for submission in the 2019/20 Blackspot round.

### COMMENTARY

The Blackspot programme focuses on high-risk rural and urban roads, focusing on the main crash types and vulnerable road users. It is an integral part of the Rockhampton Regional Council's Road Safety Strategy 2012-2022 which aligns with the National Road Safety Strategy.

High risk locations are identified through an online software package called Webcrash. Webcrash is a mapping based program that is linked to the Police and the Department of Transport and Main Roads (DTMR) traffic accident databases. The Webcrash program ranks crashes in location based on the number of crashes and the crash severity. The top 50 locations based on this crash history have been used to develop a priority list.

An appropriate traffic management treatment is then developed for each location. An assessment of the current road geometry and causal factors surrounding the crash history is undertaken. DTMR provide a list of treatments and their assumed crash reduction factors as a guide for treatment.

As part of the grant application process, a benefit cost analysis is performed on each proposed site. This is based upon the benefits of the proposed treatment measured against the crash history. To be eligible for Blackspot funding, the proposed treatment must score a Benefit Cost Ratio (BCR) of 2.0 or greater.

As part of the submissions for the 2018/19 Blackspot funding, RRC provided 6 applications for various high crash locations. These identified locations and the proposed treatments at each are summarised in **Table 1** below, which also indicates that of the 6 applications made, funding was only approved for one of the proposed projects.

In regards to the upcoming 2019/20 round of Blackspot funding, nominations for projects are now open with applications required to be submitted by 27<sup>th</sup> July 2018. Based on a review of the latest crash data throughout the region, the following locations have been identified for further investigation to determine suitability for Blackspot funding:

- Razorback Road (Road Link).
- William Street / Davis Street intersection.
- Glenmore Road / Main Street intersection (resubmission).
- Richardson Road / Redhill Access intersection (resubmission).
- Moores Creek Road / Feez Street / Kerrigan Street intersection.
- East Street / Derby Street Intersection (resubmission).
- Moses Road Dalma Ridgelands Road intersection (proactive submission under Road Safety Audit).

The resubmission of the three projects previously submitted is recommended as additional crash data have been recorded in the last 12 months, which has improved the BCR.

#### BACKGROUND

The Federal Blackspot Program is a federal funding grant, administered by the State, to improve the safety at Blackspot locations. A blackspot intersection is defined as an intersection with over 3 casualty crashes in the past 5 years. The blackspot program aims to fully fund the works submitted in the application and the works must be completed within the nominated financial year.

Rockhampton Regional Council adopted the *Rockhampton Regional Road Safety Strategy* 2012 – 2022 in November 2012 and the associated Action Plan in June 2013. The Strategy outlines shared road safety priorities for stakeholder agencies based on consultation, a comprehensive analysis of crash trends, and an understanding of local transport needs.

An investigation into the effectiveness of the historically completed treatments constructed through Blackspot funding identified that between 2002 and 2015 RRC received funding to upgrade 27 sites totalling \$5,301,000. While the implementation of the identified treatments

at these sites provided a total estimated saving of \$4,062,763.50 per year in targeted crash costs, or an average annual saving of \$150,472.72 per site.

The findings of this investigation also identified that the treatments implemented under the Blackspot Program had a dramatic effect on crash reduction at the sites, with a 54.58% drop in all crash types and a 43.26% reduction in crashes specifically attributed to the installed treatment type (i.e. target crashes).

Projects nominated under the Federal Blackspot Fund will receive up to \$2.0M in funding. Although Council can elect to contribute to the project, a contribution to Blackspot proposals is not mandatory.

### **RISK ASSESSMENT**

The Federal Government Blackspot Funding programme assists Council and State Government Departments to reduce the number of casualty and fatality crashes within the Rockhampton Regional Council area. The systematic treatment of Blackspot identified intersections reduce the overall crash risks within our region.

### CONCLUSION

Rockhampton Regional Council continues to submit applications for the Federal Blackspot funding each year to progressively address some of the unsafe intersections in the region. This report outlines the processes followed during the application process and provides an update on the outcome of the 2018/19 submissions and the recommended submissions for the 2019/20 Blackspot funding program.

### SUMMARY

The following report contains the proposed application for Round 7 of the Community Road Safety Grants Scheme for Council consideration and endorsement.

### OFFICER'S RECOMMENDATION

THAT Council endorse the proposed project to submit under the Community Road Safety Grant program.

### COMMENTARY

Council has been invited to participate in the State Government Community Road Safety Grant (CRSG) program. The program provides opportunities for community organisations to support local road safety initiatives with a road safety and educational benefit, drive a fundamental culture change and attitude to road safety in local communities, and encourage innovative new ideas that address current and future local road safety issues. The Round 7 program will fund small scale local projects up to \$20,000 with applications closing on 25 May.

The project criteria mainly relate to road safety education and awareness programs for various vulnerable road users. Officers are proposing to nominate one project for the CRSG Round 7 to improve road safety education and awareness of speeds in local residential streets. This is through the introduction of portable electronic speed warning signs on local streets in the region.

Rockhampton Regional Council (RRC) regularly receives complaints from members of the community with regard to vehicles speeding in local streets, and requests for Local Area Traffic Management (LATM). Speeding in local streets is an ongoing issue throughout the region and one which is difficult to address. Council officers are required to quantify evidence of speeding when these complaints are made or when LATM is requested. The deployment of Portable Speed Warning Signs (PSWS) can be implemented as an initial step in RRCs Local Area Traffic Management (LATM) procedure.

Deployment of the PSWS will have twofold benefits. Firstly the PSWS will increase driver awareness of the speed limit and warn drivers if they are exceeding the posted speed limit by displaying the vehicles speed and/or a message such as "Slow Down" on the electronic display. This will increase awareness of the posted speed limit and provide a quick and visual response to a speeding complaint. Secondly, the PSWS devices have the ability to detect and record speed data as low as 5km/h. The devices will be able to quantify speeding issues in local residential streets, reducing the need to install traffic count tubes in some locations. With measurable speed data, officers can analyse the data and, if required, progress to the next stage of the LATM procedure.

Officers are seeking to secure 1 solar portable speed warning sign and 1 solar portable speed warning sign including a trailer at a quoted cost of \$19,973. The intent of the trailer mounted sign is be deployed in streets when officers receive new speeding complaints. The other sign will be used for ongoing speed awareness in streets where officers have evidence of an existing speeding problem. This will be used to supplement Queensland Police Service (QPS) enforcement with recorded data passed onto QPS for their information. It is envisaged that awareness of this project and its outcomes will be raised through media and marketing between Council, DTMR, and Queensland Police Service.

### BACKGROUND

The Community Road Safety Grant Scheme is in its 7<sup>th</sup> Round of funding and aims to support the development and delivery of effective and innovative road safety projects which address and educate on local road safety issues. Council Officers are proposing to submit one application for Portable Speed Warning Signs to improve road safety education and speed awareness in local residential streets.

The proposed project will address RRC's Road Safety Action Plan 2012 - 2022 by identifying and trialing innovative initiatives from other jurisdictions, designed to increase knowledge of, and compliance with speed requirements.

### PREVIOUS DECISIONS

Nil

#### BUDGET IMPLICATIONS

Projects nominated for the Community Road Safety Grant will receive up to \$20,000 in funding. Although Council can elect to contribute to the project, a contribution to Community Road Safety Grant proposals is not mandatory.

#### STAFFING IMPLICATIONS

Implementation of the project would be carried out by technical officers who currently undertake similar work as part of the strategic traffic count program. It is envisaged that the use of portable signs will decrease the work involved to quantify speeding complaints.

### **RISK ASSESSMENT**

Proposing projects under the CRSG does not represent a significant risk to Council. The proposed use of PSWS devices will improve road safety in the Rockhampton Region by encouraging drivers to slow down on local streets.

### CORPORATE/OPERATIONAL PLAN

3.1.1 Consult on, advocate, plan, deliver and maintain a range of safe urban and rural public infrastructure appropriate to the Region's needs, both present and into the future.

#### CONCLUSION

The Community Road Safety Grant Scheme Round 7 is currently open and officers wish to nominate one project to improve road safety education and speed awareness in the Rockhampton Region. This nomination is presented to Council for endorsement.

### 1. Highlights

#### **Design Services**

Major design projects completed in April include:

Yaamba Road On-Road Cycleway (Stage 1) Yaamba Road Off-Road Cycleway (Stage 1) Dean Street Drainage Power Street Upper Dawson Road

A review of the Rockhampton North Arterial Upgrade project at Parkhurst has been completed by officers from the Civil Design, Strategic Infrastructure, and Development Engineering Units, and comments forwarded to TMR.

#### Development Engineering

Building Over/Adjacent to Local Government Sewerage Infrastructure Policy/Guidelines review has been conducted and is with FRW for comment before finalising.

Stocklands' representations on the draft approval conditions has been received and is being reviewed prior to a follow up meeting with their consultants before issuing the decision notice.

#### Strategic Infrastructure

The Flood Hazard and Stormwater Management Planning scheme policies have been updated. Overland flow-path mapping is progressing well to clearly delineate between mainstream flooding and overland flow.

The Riparian Corridor Management study for Frenchmans and Thozets Creeks has recently commenced.

Infrastructure planning is underway for the Gracemere Industrial Area and Parkhurst Strategic Road network to a preliminary evaluation stage as part of the State's Maturing the Infrastructure Pipeline Program.

### 2. Innovations, Improvements and Variations

During the design of Thirsty Creek Road, Civil Design staff have utilised the RACAS Asset Management System to assist with the design of 15km of rural roadworks. The RACAS system has a street view photo at 5 metre intervals with positional certainty, allowing objects visible in the photographs to be accurately plotted onto CAD drawings.

Traffic count data is now automatically updated into Geocortex.
