#### **SUMMARY**

This report provides a recommendation for the naming of a new road being constructed for the Bajool waste transfer station and seeks Council's adoption of this name.

#### OFFICER'S RECOMMENDATION

THAT the road located off the Bajool – Port Alma Road, connecting to the Bajool waste transfer station be named 'Old Joe Road'.

#### **COMMENTARY**

Council's Naming of Infrastructure Assets policy has been applied in response to the opening of an unconstructed road as shown in Attachment 3. Two submissions were received, nominating two potential road names. These submissions are included in Attachment 1 (included in Confidential for Privacy provisions).

An assessment panel consisting of Council Regional Services officers was established to evaluate the nominated road name. The nominations have been considered and graded against the criteria set out in the Naming of Infrastructure Assets Policy on a scale of 1-5. One being the submission does not align with the criteria, five being the submission accurately reflects the criteria.

The following table lists the names proposed, the number of nominations received for each, the assessment panels scoring and the resulting rank. (Attachment 2 contains full assessment criteria and scoring (included in Confidential for Privacy provisions)).

Proposed Name	Nominations	Score	Rank
Old Joe Road	1	35	1
Connorgins Road	1	31	2

The submission for "Old Joe Road" rated with a high score as a result of the assessment against the criteria.

At a recent ratepayers meeting on 15<sup>th</sup> February, the name 'Old Joe Road" was nominated by the group. There were 40 people in attendance at the meeting.

According to the nominators, Joe lived in a corrugated iron bush shanty at the end of the unnamed road. He was known affectionately as 'Old Joe' by many long term residents of Bajool.

Considering the number of people supporting this name as nominated at the rate payers meeting, and the higher score against the criteria, the assessment panel considered naming the road after 'Old Joe' as appropriate for a small community road.

There are no reserved names on the Unallocated Road Names Register for the locality of Bajool.

#### **BACKGROUND**

In November 2018 Council's Waste and Recycling Manager requested a name for a road being constructed for the Bajool waste transfer station. The road will be opened as per Councils 'Opening of Unconstructed Roads' policy adopted in March 2013. This road is due to be opened in the first quarter 2019, and further to being named, will be added to Councils Road Register.

In accordance with Council's Policy 'Naming of Infrastructure Assets', nominations were sought from the public and community groups submitting a name for the consideration of Council.

The procedure adopted by Council requires that advertising be undertaken calling for nominations of names by placing a notice on Councils website and a public notice placed in a Saturday edition of a local newspaper.

Nominations were called for in The Morning Bulletin Public Notices on 15 December 2018 with submissions and a notice placed on Councils website.

One nomination was received from the advertising and further nominations were sought via a rate payers meeting held in February 2019 to solicit suggestions and nominations. A further nomination was received, with the support of 40 people at the meeting.

#### PREVIOUS DECISIONS

The Naming of Infrastructure Assets policy was adopted by Council at its 16 December 2008 Meeting. The applicable policy is now Version 2 of the Naming of Infrastructure Assets adopted in January 2017 and its associated procedure.

#### **BUDGET IMPLICATIONS**

The cost of signage is dependent on size, but is estimated to be under \$500.00 including installation.

#### **POLICY IMPLICATIONS**

The applicable policy is 'Naming of Infrastructure Assets' and its associated procedure.

#### CONCLUSION

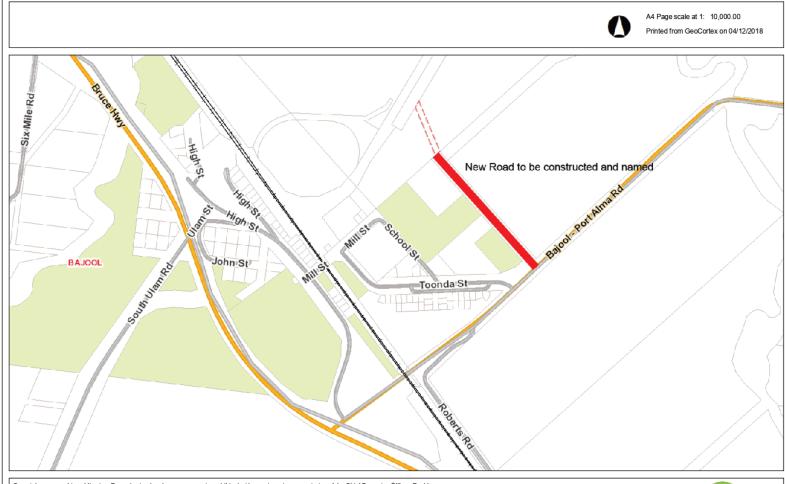
Based on the results of the assessment criteria, it is recommended that Council endorse the name "Old Joe Road".

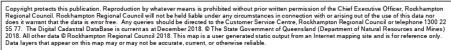
# NAMING OF ROAD LOCATED OFF BAJOOL - PORT ALMA ROAD

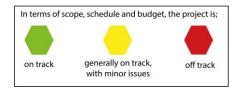

# **Strategic Infrastructure**

Officers have been working with Development Engineering Unit to review aspects of the Capricorn Municipal Development Guidelines for Road Design and Erosion and Sediment Control. This involves updates to design elements, incorporating updated guidelines and adopting best practice engineering.

A concept design brief for the Mt Morgan to Gracemere Rail trail has been developed to understand potential opportunities and challenges associated with the construction of a rail trail. This included a concept cost estimate to help facilitate discussions.

Sewer network modelling has been taking place to review of the future water and sewer infrastructure schemes as part of an upcoming LGIP review. These have involved considering the currently proposed schemes and whether they are still necessary to service future development.

Officers have been preparing some survey and modelling work for an invitation to tender for drainage design works in Gracemere. Some initial ground truthing work has been done to inform the information provided for a successful tenderer.

# **Assets and GIS**

# **Bridge Condition Assessments**

Officers continue to perform routine condition assessments and defect monitoring activities as planned. Officers have been working with ARRB to finalise the scope of works for the level 3 bridge investigations associated with the following structures:

- High Street Bridge Moores Creek
- Kerrigan Street Bridget Moores Creek
- Kerrigan Street Major Culvert Frenchmans Creek

# **Asset Data Reviews**

Work continues on the review of Council's asset data in both GIS and Conquest.

# **Disaster Management / SES Operations**

# November Fires Gracemere and Kabra

Internal debriefs continued in February, and an action plan has been drafted. In particular attention has been given to the Rockhampton Zoo, and Evacuation Centre Management. Work continues regarding Bushfire Mitigation within the Rockhampton Region.

The State Recovery Coordinator visited Rockhampton, to receive an update on the Recovery status, while also to provide updates on potential Cat C funding opportunities.

# Townsville Monsoon Floods

Council's Coordinator Disaster Management was deployed to the Townsville activation, within the Australian Red Cross Field Operations team between 06 – 10 February, to assist establish the Field Incident Management Team Coordination Centre. The Coordinator also had the opportunity to be a part of the establishment of a Community Recovery Hub, established to provide psychological first aid and connect residents to the multiple agencies that are able to provide support. Learnings will be shared and considered within the local disaster management practices.

Members and plant/equipment from the Rockhampton State Emergency Services Unit were deployed to support both the Townsville Monsoon Floods and the Western Queensland Flooding events.

# **Guardian Control Training**

Between 26 and 28 February five training sessions where held allowing for 46 RRC staff and members of the LDMG to attend a session, and become familiar with the event management system. QITPlus facilitate Key User Training, Administration and Reporting and three General User training sessions.

- Ongoing engagement has occurred to help facilitate rectification options of mobile blackspot issues around the Mt Morgan SES Headquarters and township.
- Ongoing support to SES QFES on finalisation of Taskforce Catalyst and the State Communications Standards committee for improving SES capabilities; LC has been working closely with QFES on many areas in support of SES/QFES and LG Partnerships.

# 2. Innovations, Improvements and Variations

# **Strategic Infrastructure**

Strategic infrastructure are in the process of undertaking a trial project with DTMR whereby access to HERE Data is made available to Council. HERE Traffic Data provides Council with a large dataset of Speed Data to analyse historical traffic information. Speed Data is a data product that provides a record of traffic speed observations on roads. Based on GPS probe data it delivers historical traffic speeds for analytical applications. This data set allows officers to investigate speed requests more efficiently than before as the need to install traffic counting tubes will be removed. As this is a trial project, officers will check the accuracy of the data before its widespread use.

# 3. Customer Service Requests

Response times for completing customer requests in this reporting period for February 2019 are within the set timeframes.



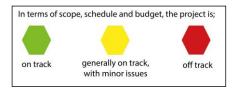

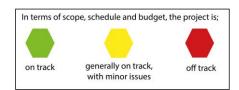
