Guidelines

- Please contact Council to confirm availability prior to submitting this form on 07 4932 9000.
- Banner poles are for use by Community/Not-for-Profit organisations only.
- Banners can be displayed for only four weeks prior to the event.
- Banners must be removed by 6pm on the last day of the booking.
- Banner bookings will only be accepted three months prior to your event.
- Council reserves the right to remove any unauthorised banners or banners placed in the incorrect approved site.
- Banners are to be made out of nonhazardous material. No metal or hard plastic banners are permitted.
- Banners are to be secured with cable tie or rope only.
- Moores Creek Road (Colts) banner poles will accommodate banners as show in Diagram.
- Stapleton Park (PCYC) banner poles will accommodate banners as show in Diagram.
- Please contact Customer Service if your Community Banner is larger than the applicable size as alternative arrangements will need to be made.
